

TABLING OF 2014/2015 BUDGET SPEECH BY THE EXECUTIVE MAYOR COUNCILLOR VUSIMUSI TSHABALALA DURING THE PRESENTATION OF THE BUDGET ON 12 JUNE 2014 AT RIVERSIDE

Madam Speaker, fellow Councilors, ladies and gentlemen who I recognize according the order of precedence of the state, council officials and members of the community and media corps please join us as we proclaim again that Together we move South Africa forward. This the historic call by the ANC. One of the founding fathers of the ANC Pixley ka Isaka Seme made this uplifting remark when he was much younger than I am today and I quote:



'In all races, genius is like a spark, which concealed in the blossom of flint, bursts forth at the summoning stroke. It may arise anywhere and in any race'.

As a loyal cadre of the ANCI invoke this optimism of our pioneer to ignite the genius in this council so that it becomes part of the national good story. The story I wish us to tell through this budget is that of a clean audit. And I wish to point out that three critical pieces of legislation being Municipal Finance Management Act, Municipal Systems Act and Municipal Structures Act refer to Executive Mayor.

That implies that the incumbent of such an office must **EXECUTE POLICY** as a legislative requirement .

Therefore the Executive Mayor will through the MAYCO, Municipal Manager and the administration execute the budget without hesitation. Anything less would undermine the legal





framework of the country, betray the authority and diminish the revolutionary calling of the historic office of the Executive Mayor. Believe me nothing will ever make betray this sacred duty. Destiny has favoured me with a dedicated MAYCO made up of the following cadres;

Under the direction of an able Chief Whip Clr Thebe, we ready for work to write a chapter in the national good story.

At the outset, we must point out some socio-economic evils that **Employment Equity** and all other transformation instruments are intended to remedy. The mind is filled with discriminatory labour practices like **Job Reservation**. Land ownership is one graphic evil that warrants bold and radical reversal. For an example in Harrismith an ordinary residential site in Ntabazwe is a third of the same in town in size. This means that blacks had their dignity and comfort reduced. The sad legacy of apartheid is long and hurtful to us.

We have taken comfort and renewed our resolve on the 7<sup>th</sup> May as millions voted emphatically for the good story to unfold deeper until its effect reaches all the deserving people of our land. With these elections our people have directed that we should accelerate the pace and intensity of change.

Therefore, we shall be utilising the budget we table today to give necessary speed to change. Together we move South Africa forward. Ka hoo ho jewa fatshe.

## 1-Building an inclusive economy that creates jobs

Local Economic Development (LED)must be placed under constant review to align it with the economic challenges that change with changing times, without forewarning to all of us.

In this regard, I will closely lead and direct the **LED** unit to ensure that it responds optimally to the huge task that attach to the Inland Logistics Hub proclaimed for construction in Harrismith. We must remember that this project forms an integral part of the Gauteng-Free State-KZN logistics corridor. Out of the roll out of this project especially in Harrismith there will be increased job creation across the spectrum.

I would want to put my fingers on the pulse of this project so that I can always be heads up about its unfolding. Above this, we have since applied for the status of **Special Economic** 





**Zone** (**SEZ**). When approved and a proclamation issued in the government gazette then we can attract huge investments.

By now, we know that the SEZ and their predecessors the IDZs process create many jobs as the Dube Port has shown in KZN. We will send a delegation on a knowledge-gathering mission to the Saldanha Bay municipality so that we can acquaint ourselves with the administrative mechanisms of an SEZ. The SEZ must be a platform from which we can expand the economy of the district.

We should draw lessons from the closure of factories like Circuit Breakers Industries, many more in the textile and furniture factories. Those lessons must inform us to inject more attention on industrial development. The DTI has many interventions that we must help channel to our business community. One key lesson is that we have to strive for a diversified economic base. We are happy to record that the municipality is busy negotiating funding agreement with Standard Bank for the SMMEs and industrialists. In the immediate future, the municipality will be signing an MOU with BELL Company to invest in Maluti-A-Phofung that will create most needed job and economic growth.

The creation of the new Ministry of Small Businesses by President Zuma must give our LED fresh inspiration to seek more ways to grow the economy of the municipality. Madam Speaker the economic success of countries like Indonesia and Brazil were driven by SMME empowerment. Therefore, we will not hesitate to take actions that advance SMMEs.

I sincerely hope that the payment arrangements for services rendered by SMMEs to this municipality are conducive to their success. To this end I wish to indicate that SMMEs service providers must be high on payment priority all the





time. In January we launched an Integrated Energy Centre at Makwane in conjunction with the national department of energy. Out of it we created 14beneficiaries through a joint investment of R14m by the department and the municipality.

We have rekindled the spirit of the exhibition show that characterized QwaQwa. The inaugural show (**DIPONTSHO**) took place in April 2014 and has contributed immensely to the tourism sector and helped market our municipality. We have no doubt that the next show will be a notch higher. The main purpose is to create information sharing platform and to entertain through local talent mainly while employing national talent to serve as motivation.

**Madam Speaker** we have noted that communication and the ICT are crucial for the economy. After we had experienced some connectivity problems, we have interacted with the two network operators to enhance cell phone coverage to 2G and 3G. We thank both MTN and Vodacom for their cooperation in this regard.

Through Inter Government Relations we have undertaken the upgrade of the historic Mountain resort with an investment of R19m, upgrading of the Sentinel road as well as the completion of the Mabolela Guest House. We had to restore the Mountain Resort which was a community project spearheaded by the late Morena Wessels Mota and the Batlokoa of Manthatisi of Tsheseng in the late 1950s and early 1960s.

The history of its building is unbelievably inspirational **Madam Speaker** I tell you.





## 2-Expand comprehensive social security

Working with **SASSA** and department of Social Development, we will constantly evaluate our social security interventions. On our part we shall continue to enlist more deserving people Indigence Register. When we couple interventions, we then place an effective social security net. It cannot be a SASSA alone matter. Conversely it cannot be a municipality alone matter. To make our input to the good story appealing we will still accommodate deserving people who could not enlist in the Indigence Register for another three months. We will be participating in a joint effort with department of social development in the creation and maintenance of a Food Bank. The aim is to assemble donations of from kind people so that we can distribute to the needy. We will inform the council when the bank opens.

di-CCTV Camera tse **14** di tla kenngwa Harrismith hodima tse **30** tse Phuthaditjhaba.

Sepheo sa tsona tsa sethato eneng ele ho lwantsha boshodu ba diphoofolo. Tsena di kentswe ka ditjeho tse kana ka **R4** m. Tsena di-CCTV di tlile ho fokotsa bokgothotsi.

Moo masepala a dutseng mosikong wa thaba tsa Maluti, re moo meya, mahlwa le meya e tsukutlang e leng mengata. Ha lehlwa le wele haholo tseleng ya N3 Van Rheenen's pass ho ba le tshitiso ya ho tsamaya. Sena se hlokofatsa moruo wanaha hampe.Kahoo re lokela ho ba malala a laotswe ho thusetsa ha lehlwa le kwetse ditsela. Le sehla sa meya e meholo se fihla ka Phato(July). Mona re tlo tsukutlwa ke ho thja ha hlaha, empa re motlolto ho etsa tsebiso hore re rekile lori ya setima-





molloka **R4m** ho thusa ka ho lwantsha mello ena ya dithota le mello kaofela. Mello ena e bolaya mehlape le diphoofolo tsa naha le hona ho tjhesa dijalo tse komisong.

## 4.2- Tshireletso ya tikoloho- Environment Security-

Ha o sheba dinokeng le dithabeng tsa rona otla bona difate tse kwalang dinoka. Le lehlaka le tlalang dinokeng le senya tikoloho. Botlokotsebe bo runya moo. Tsena di lokela ho tlosa le hore re thibele ho tsholohela ha kgwerekgwere dinokeng. Hape re tlameha ho lwantsha tshilafatso e etswang ke lerata.

Re tlamehile ho sebetsa mmoho le **SAPS** ho thibela lerata le lengata metseng le mabenkeleng. Re tlamehile ho fuputsa hore na re ka reka metjhini ya ho bokella matlakala e bitswang **Skip-loader** hore re behe **di-Skip** tsena hohle moo setjhaba seyeng se qhalle matlakala teng.

## 4.3- Matlo le ditshebeletso- Housing and amenities-

Masepala o tlamehile ho theha ditsha tsa bodulo ho lwantsha thlokeho ya bodulo. Mme re tlameha ho sebdisana le Marena hore phano ya ditsha ebe e laolehang tlsasa SPD. Ke ka hoo re bileng le ketsahalo e sa hlaboseng empa e tlamehileng ba ho ba teng ya ho thibela ho nkuwa ha naha mane pela University. Le hae batho ba tlositswe moo maobane, re nkile mehato ya molao ho tloha sethatong. Re bile re fane ka bodulo ba nakwan ha re sa ntse re hlophisa osa sebaka sa kaho ya matlo bakeng sa ba amehileng. Ho teng matitjhere, mapolesa, basebeltsi ba mmuso le bo-rakgwebo ka kgasang (Gap Market) ba hloleha ho fumana thuso ya di-banka bakeng sa ho reka matlo.





Mona re lokela ho romela moifo ho ya kopana le Housing Development Agency (**HDA**) ho ithuta hore **HDA** eka re thusa jwang ho reka naha bakeng sa kaho ya matlo.

We must initiate Public Private Partnership developments and also consider those presented even if they were unsolicited. This will assist us to respond to pressing service delivery challenges where funding is a problem or limited. We have noted some areas of concern being waste management, water demand management and sanitation. In particular there has to be a concerted effort to plug all leakages and to stop spillage of sewer into the water system. The right of communities to clean water is critical and a constitutional provision. And I am particularly proud that we are the only municipality the province that has been awarded a **Blue Drop Certificate** ( **metsi a hlwekileng a pompo a o motho a ka anwang**) for the past three years.

Dithloko tsa ditoropo tsa rona ha di tshwane ebile ke tshwanelo hore ho be jwalo. Feela re lokela ho kenya ditlhoko ka hara Moralo wa Ntlafatso ya naha (**Spatial Development Plan**). Ka ha re tseba hore ho lokela ho etswe eng kae, le hona neng ka bokae, re nale bokgoni ba ho lebisa ntshetsopele moo e hlokehang teng. Ha o sheba Schoonplatz Harrismith moo mmuso o tsetetseng tjhelete e kana ka **R118m,**o tla fumana hore re kgotlisetsa lefatse ho beng ba lona. Mmuso wa kgethollo o ile wa tlosa baahi ka lonya moo Schoonplatz mme re tlisa toka ka projeke ena.





Mme Harrismith/Ntabazwe/Tshiame re tsetse thjelete e kana ka **R85m** ho kenyelleditse Schoonplatz. Mona re tlisitse projeke tsa ntlafatso ya phano ya metsi a mangata/ bulk water upgrade, sebaka sa dipapadi se kwalehileng/indoor centre, tlhwekiso ya dikgwerekgwere/waste treatment le ditsela. Tsena ke tse ding tsa ntlafatso tseo re di tlisitseng.

Thlolong teng re ahile ditsela le ho ntlafatsa phepelo ya metsi le ho aha marogo a maoto/ foot bridges, tsohle ka tjeho tsa R14m. Makgolokoeng teng re isitse diprojeke tsa ditjeho tsa R4.6m bakeng sa dikgwerekgwere le phepelo ya metsi.

Ha re kena QwaQwa teng, re dietse dikgala ka projeke tse jeleng **R135m.**Tsona ke tsa metsi a mangata/ bulk water, ho kampela mabitleng/ fencing of cemeteries, VIP toilets ,ditsela, high mast lights,tsamaiso ya metsi a dikgohola le tse ding.

#### 4.5- Thuto- Education-

Ho ya ka molaotheo phano ya thuto ha se mosebetsi o matleng a masepala, feela re nka karolo phanong ya thuto. Mme re motlotlo ka moo baithuti ba sehlopha sa **GR12** ba selemo sa **2013** ba sebeditseng ka teng. Re bile ra fana ka dibasari tse **94**. Mona re lebelletse ho eketsa thuso ena ha baithuti baka ba fetela pele ka dithuto le ha re kenyelletsa ba sehlopha sa **2014**. Ke thapelo tsa pelo tsa rona hore baithui bana ba fumaneng dibasari, ba ithute ba se ke ba senya tjhelete ya setjhaba.

Re boetse re sebetsa mmoho le mafapha a thuto.Re kgahlametsa dikolo le di-college tsa **FET** le **university** ka ditshebeletso. Projeke ya manthla ya kantoro ya majoro ke Contractor Development . Tjhelete eo re e behileng bakeng sa ho nthlafatsa bokgoni borakgwebo ba thuthuwang (SMMEs) bao eleng borakontraka ba kaho ke **R20m** .





Mona re tla netefatsa hore bomme le batjha ba borakontraka eba karolo e kgolo ya lenanao lena. Haholo re batla hore ba kgone ho ho fumana mangolo a Civil Engineering le a General Construction ho ya ka Construction Industry Development Board (CIDB).

## 4.6 -Ditsha tsa kgwebo le difeme- Commercial and industrial facilities

Hore re tsebe ho theha moruo o akaratsang bohle o bile o theha dikgeo tsa mosebetsi,re lokela ho sheba hore ebe ha re hloke setsha se seng sa mabenkele Phuthaditjhaba. Re tlo tlameha ho buisana le beng ba Setsing Shopping Centre hore ba shebane le tshubihlellano ya makoloi Setsing.

Ke mona moo rona re tlileng ho ntlafatsa boemelo ba ditaxi/taxi rank e Intabazwe le e Phuthaditjhaba ka ditjeho tsa R30m. Sena se lokela ho rarolla bothatha ba tshubuhlellano ena ya makoloi e re e bong hae mona.

## Dipapadi, bonono le bothjaba (Sports, Arts and Culture):

Re tla dula re netefatsa hore mabala a dipapadi le mabala a ho ikgatholla le ho netefatsa hore di holo di dula di le maemong a tshebetso a amohelehang. Ke ka hoo re tlileng ho kenya ditulo tse 5000 Charles Mopeli Stadium. Sena se tla netefatsa hore dihlopha tsa PSL le NFD di ntse sebedisa lebala lena. Re tla matlafatsa phano ya ditshebeletso tse amanang le kabo ya mabitlale ho kampela mabitla jwalo ka ha se re boletse.

HO JEWA FATSHE Madam Speaker,





I have to provide you fellow councilors and the community with a pilot's view of how we applied the budget of 2013-2014. A detailed presentation fact sheet is attached to our budget document. It lists many projects that have been successfully executed or that are in execution as well as the spending going with them. From these projects you will see that we covered a wide array of spheres of community life. Indeed we have made a good effort to take Maluti-A-Phofung and South Africa forward. Madam Speaker how good can our national story be, if it did not tell us that you as council have made valuable contribution to communities of our municipality? As we have spent so well in that budget year we now present to you how we will raise money for the 2014/2015 budget.

**Madam Speaker** for the forthcoming fiscal year we have made provision for the accrual of **R1.4b** as income. This will be generated as detailed in the budget document in your possession.

Our expenditure has been structured to cater for a sustainable and efficient administrative component of the municipality. The most critical facet of the administration entails the PMU so that we can expedite the implementation of infrastructure development projects. The social services section has mitigate against child desertions, access to interventions by the vulnerable individuals in society and in general terms to strengthen the social safety net. LED must mobilise resources, opportunities and interventions aimed at growing the economy of the municipality, sports/culture to harness sports and culture as drivers of our municipal economy too and the safety, security and emergency unit to police our roads and streets as well as to respond in time to emergencies so that lives can be saved protected.





Part of the income generation drive will entail arresting the stealing of electricity. At the moment we owe ESKOM R266m and we are well on the way to remove this debt. In order to achieve this we are going to criminalise stealing electricity to the extent that all civil servants and municipal workers who will be caught after 30<sup>th</sup> September 2014 will be charged with misconduct at their respective work places. Then we will go after all others who steal electricity. We encourage all those at fault to approach our office to regularise their electricity meters at a lower fine.

If by 30<sup>th</sup> September 2014 they have not come forward, then we will unleash the might of the law. Even more we will find systems and technology that will allow us to collect outstanding rates and taxes through a percentage of electricity purchases every time by affected individuals. We will work hard to collect all other revenue outstanding. Proposals that can make this efficiently are welcome. We will continue to pursue all property owners to pay outstanding rates and taxes. As some of the government agencies are still stubborn, we will approach the Premier to instruct them to pay up so that we do not have a bad precedent of non-payment. May we thank all the rate-payers and those electricity users who pay their dues without undue delay.

Naturally funding is required for the management of council matters and compliance with statutory provisions on the role of council and the EXCO in pursuit of their interlinked objectives. It is particularly vital that we should seek integration of activities of all the government organs in our area. In this manner we will be able to consolidate the effects of service delivery so that the good story can continue to unfold.

Colleagues there is just a lot of work we have to do for our communities.





Towards this end the expenditure of **R1.3b** with the breakdown is indicated in the circulated budget document. The capital and infrastructure project expenditure will be **R308m**.

# Madam Speaker I now present the proposed tariff increases that will take effect with the new financial year.

The following stipulations in the Property Rates Policy are high-lighted:

The first **R80 000** of the market value of a property used for residential purposes is excluded from rate-able value in addition to this 5% rebate will be granted to rate payers who will pay their rates account before the due date which is the 7<sup>th</sup> of every month

**100** per cent rebate will be granted to registered indigents, Old age and state pensioners in terms of Indigent Policy

**100** per cent rebate will be granted to registered non- profit organisation

#### **INCREASES IN TARIFF CHARGES**

We shall implement the following tariff regime upon the coming into effect of this budget. We have tried to keep them at a minimum so that for those who have to pay, the burden should not be heavy. All tariffs save rates and taxes as well as electricity will be adjusted by 5% while electricity will be adjusted by 7.36%. Rates and taxes will not be increased.
